



TFWA630: TERRAFIRMA WIDE ANGLE REAR PROPSHAFT

DEFENDER 90 – 2007 ONWARDS - TDCI

FITTING INSTRUCTIONS

- 1. Park the vehicle on flat level ground, chock all four wheels front and back.
- 2. Raise one rear wheel just enough to clear the ground then support the axle and vehicle on axle stands.
- 3. Undo the four nuts and bolts at the rear diff end of the rear propshaft. It will be easier to work round all four nuts and bolts with the vehicle out of gear, the handbrake off and one rear wheel off the ground so the propshaft is free to rotate.
- 4. Undo the four nuts at the handbrake drum end of the transfer box; these bolts are captive within the handbrake drum.
- 5. The propshaft may need a gently tap with a soft faced hammer, when loose remove the rear propshaft. It will have to be pulled off over the captive bolts in the handbrake drum.
- 6. Clean the flat surface on the handbrake drum and rear diff flanges.
- 7. Lift the new propshaft up into place.
- 8. It is recommended to fit the new propshaft with new nyloc nuts and bolts (part numbers NZ606041L & 509045P).
- 9. Fit the new propshaft over the captive bolts on the handbrake drum fit the new nyloc's and then tighten.
- 10. Fit the new bolts through the rear diff flange and then through the new propshaft fit the new nyloc's and then tighten.
- 11. Grease the U.J's and the slider.
- 12. Lower the vehicle off of the axle stands.
